We have a legislative listserv group that any member of WASPC can received, and you will get daily updates on bills, hearings, and fiscal information. The listserv also serves to allow you to provide input. I just want to make sure everyone knows you do not need to be appointed or be approved by anyone to get the information. It does not obligate you to attend future Legislative Committee meetings, although we'd love to see you there!

By now, I hope you have already put our **Law and Justice Day** on your calendar- January 29 at 9:00 AM in the Columbia Room at the Capitol. We will start with the legislative briefing from our Policy Director, James McMahan, and then some comments from key legislators.
